## CLARK REGIONAL WASTEWATER DISTRICT BOARD OF COMMISSIONERS MINUTES REGULAR MEETING April 10, 2018

The first regular meeting of April was held at the District Board meeting room, 8000 NE 52<sup>nd</sup> Court, Vancouver, Washington on April 10, 2018. Commissioner Kimsey called the meeting to order at 4:00 PM.

AB #18-031 – Union Road Force Main Upgrade Project Construction Contract

Award – Robin Krause briefly reviewed the agenda bill.

Commissioner Kiggins moved to award the construction contract as advertised for the Union Road Force Main Upgrade Project to Clark and Sons Excavating Services, authorize the

General Manager to sign a contract with Clark and Sons Excavating Services for the bid amount of \$583,615.20 (including sales tax) and further authorize the General Manager, or written designee, to sign supplemental amendments not to exceed ten (10) percent of the original contract amount.
