Applicant understands, represents and acknowledges as follows:

1. Sewage from the property will flow through the District's collection system and be processed by a transmission system and/or treatment plant owned and operated by an agency other than the Clark Regional Wastewater District.
2. Prior to obtaining sewer service for the Property, which may include extension of the District's sewer system by the District or the Applicant, the District and the Applicant may need to obtain other permits, approvals and authorizations from Clark County and other governmental agencies, which may impose conditions on such permits, approvals and authorization that make impractical or impossible the provision of sewer service to the Property.
3. Prior to obtaining sewer service for the Property, or any part thereof, the Applicant will need to obtain a building sewer permit from the District and otherwise comply with all District resolutions, Code provisions and regulations.

THE DISTRICT DOES NOT GUARANTEE OR REPRESENT THAT ANY TRANSMISSION SYSTEM THAT IS NOT OWNED BY THE DISTRICT WILL HAVE ADEQUATE CAPACITY TO ACCOMMODATE THE SEWAGE FROM THE PROPERTY WHEN THE APPLICANT DESIRES TO CONNECT THE PROPERTY TO THE DISTRICT'S SEWER SYSTEM. THUS, THIS RUR DOES NOT CONSTITUTE AND MAY NOT BE RELIED UPON BY THE APPLICANT AS THE DISTRICT'S GUARANTEE THAT SEWER SERVICE WILL BE AVAILABLE WHEN THE APPLICANT DESIRES TO CONNECT THE PROPERTY TO THE DISTRICT'S SEWER SYSTEM OR APPLIES TO THE DISTRICT FOR SEWER SYSTEM SERVICE.
