#### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of the Clark Regional Wastewater District from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash receipting
- Procurement small works roster and prevailing wages
- Payroll
- Open public meeting minutes

#### INFORMATION ABOUT THE DISTRICT

The Clark Regional Waste Water District, formed on May 22, 1958, provides sewer services to over 30,500 accounts in unincorporated Clark County and the City of Ridgefield. The District's customer base is comprised of both residential and commercial customers. The District operates and maintains approximately 600 miles of sewer lines and over 60 pump stations.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operation as well over 49 full-time employees. For fiscal year 2016, the District operated on a \$28.6 million annual budget.
