#### AUDIT RESULTS

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Clark Regional Wastewater District from January 1, 2019 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement public works and professional services
- Accounts payable general disbursements and electronic funds transfers
- Payroll gross pay, leave balances and accruals, leave cash outs, and electronic funds transfers
- Accounts receivable billing of utility charges
- Compliance with latecomer agreements
- Self-insurance for unemployment

#### **INFORMATION ABOUT THE DISTRICT**

The Clark Regional Wastewater District, formed on May 22, 1958, provides sewer services to over 34,600 accounts in unincorporated Clark County and the city of Ridgefield. The District's customer base is comprised of both residential and commercial customers. The District operates and maintains approximately 726 miles of sewer lines, over 70 pump stations, and one waste treatment plant.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operation and 62 full-time employees. For fiscal year 2019, the District operated on a \$37.27 million annual budget.
