ASSISTANCE PROGRAMS IN CLARK COUNTY

Clark Public Utilities - (360) 992-3000

In addition to their programs to help with electric bills, CPU has partnered with other local organizations to administer the federally funded Low Income Heating Assistance Program, which can help eligible customers pay for a range of home energy fuels, electricity, natural gas, oil, wood and propane.

"Help to Others" Voucher Program – Customers can receive money in the form of a voucher to help pay other city utilities.

Clark County Community Action Program - (360) 397-2130

Distributes funds to community nonprofit organizations to provide emergency needs. Examples of services provided through the nonprofit agencies include emergency shelter, energy assistance, homeless prevention through rent or mortgage assistance with case management, food, employment, and non-criminal legal assistance.
