### You can make a difference in the health of our waterways! Part 4: Your yard and garden

This series explores how your actions can make a difference and help preserve the health of our rivers and streams. Pollutants found in wastewater are often introduced in and around our homes.

## Actions You Can Take ...

## Consider the Benefits of a Healthy and Natural Lawn and Garden

What goes onto our lawns and gardens often ends up in waterways, including pesticides, fertilizer, and pet waste. We can make a difference in keeping pollutants out of our waterways and wastewater by making informed choices even in the yard and garden.

#### Grow a Healthy, Natural Lawn

A lawn is more than just grass. It is an ecosystem that can clean the air and filter pollutants before they enter our waterways. Keys to a healthy natural lawn: Mow high, often and with sharp blades. Water deeply, but not too often. Develop healthy soil and rethink fertilizers, choosing organic or natural sources.

#### Scoop, Bag and Trash Pet Waste

Pet waste can carry unsafe bacteria, viruses and parasites into the water. Wastewater treatment



is designed to treat human waste – not pet waste. Never put pet poo in the toilet, or down the drain. Scoop waste into a bag and put it in the trash.

#### Make a Natural Pesticide with Garlic

Soak four cloves for several days in one quart of cold water and then blend, strain, and pour into a bottle. Test your spray on a small hidden part of your plants to make sure it doesn't cause damage, then spray where you see insect damage or the pests themselves. Garlic spray can also kill beneficial bugs, so use wisely.

## Use Pesticides Carefully and as a Last Resort

Buy small amounts of ready-to-use products instead of concentrates and always follow the manufacturer's instructions. Spot-spray only on pests; don't spray pesticides over large areas. Have leftovers? Consider sharing with family or friends before disposal.

#### **Dispose of Pesticides Properly**

Safely dispose of old or leftover pesticides at your local household hazardous waste facility – never put pesticides down the drain or toilet. Clark County offers a Recycling A-Z directory to help you find the nearest facility for all your recycling needs at: bit.ly/crwwdrecycling

#### **Maintaining Affordable Rates**

Please note that the base monthly rate will increase by \$1 per month (2.5%) in January 2021 to \$41 per Equivalent Residential Unit, following a multi-year rate program adopted in 2018. This increase is necessary to help us keep up with rising costs while still maintaining some of the lowest rates in the area.
