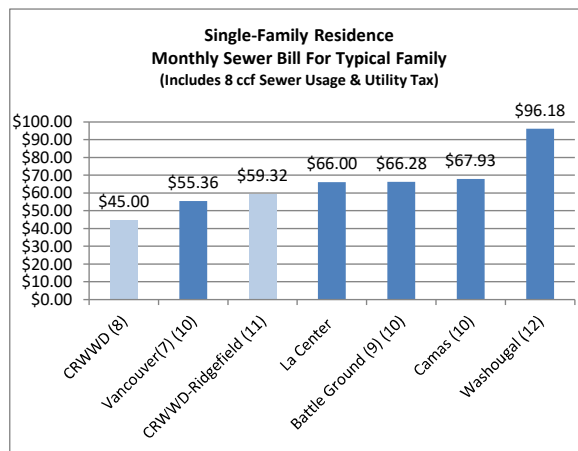
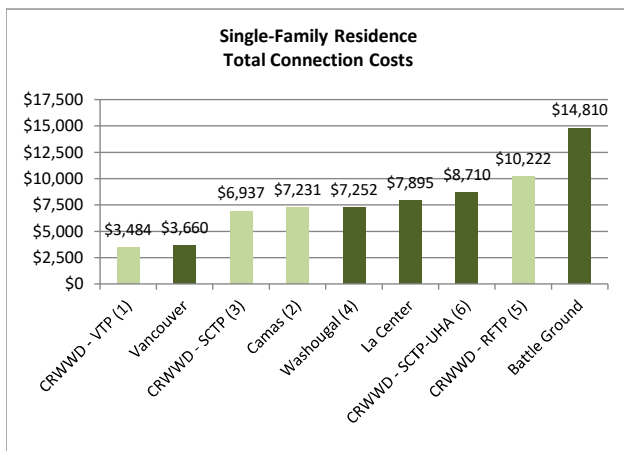

- (2) Single connection charge for Camas, including the new urban growth boundary area (mostly north of Lacamas Lake)
- (3) Connection charge for CRWWD service area flowing to Salmon Creek Treatment Plant
- (4) Connection charge for Washougal includes 1.5% utility tax
- (5) Connection charge for CRWWD service area flow originating in Ridgefield
- (6) Connection charge for CRWWD service area for 179th St./ Fairgrounds/Urban Holding Area
- (7) Vancouver utility tax is included in the monthly sewer usage fee
- (8) Monthly sewer charge for CRWWD central service area (flowing to Vancouver or Clark County)
- (9) Battle Ground utility tax is applied to sewer service fees & reduced from 22% to 12% effective 6/1/20
- (10) Vancouver has a minimum use charge of 3 ccf. Battle Ground & Camas have a base rate to which usage fees are then added
- (11) Monthly sewer charge for Ridgefield service area (flow originating in Ridgefield); includes \$11.60 system integration charge in addition to \$42 base rate
- (12) Washougal utility tax is applied to sewer service fees effective 2024.

ccf = 100 cubic feet ERU = Equivalent Residential Unit

Note: Most cities charge a higher rate for customers located outside of city limits
